No.F.8(8)/2022-Cord (3).- In pursuance of Article 218(3) of the Constitution of Islamic Republic of Pakistan read Sub-Section 4 of Section 5 and Section 181 of the Elections Act, 2017, the Election Commission of Pakistan is hereby pleased to direct that:

- (i) No Government or authority shall post or transfer any officer in the districts, where schedule for bye-elections has been issued on 28th July, 2022 and 5th August, 2022, respectively till the publication of name of returned candidate.
- (ii) No Government functionary or elected representative(s) including a local government functionary or elected representative shall announce any development scheme for the constituencies, where bye-elections are under process till **16th October, 2022.**


