No.F.2(15)/2022-LGE-B:- In exercise of the powers conferred upon it under Article 140(A) and 219(d) of the Constitution of the Islamic Republic of Pakistan, Section 219 of the Elections Act, 2017, Section 16(2) of Balochistan Local Government Act-2010 read with Rule-48 of the Balochistan Local Government (Election) Rules, 2013 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby calls upon the Members of the Local Councils (Union Councils and Urban Local Councils) in 32 Districts of Balochistan except District Quetta, Lasbela, Hub and MC Huramzai of District Pishin Balochistan province to elect the Members on Reserved Seats i.e. Women, Peasant, Worker and Non-Muslim in their respective Councils and in connection therewith appoints the following dates of various activities of elections:-

- 2. To ensure that elections to the reserved seats are conducted honestly, justly, fairly in accordance with law and to ensure that the corrupt practices are guarded against, the Election Commission of Pakistan directs that:-
  - If any person in Government Service misuses his official position in any manner in order to influence results of the elections, he shall be liable to be proceeded against under the Law;
  - After issuance of election schedule for the reserved seats of local government, no transfers / postings
    of the Officers and Officials appointed in connection with election shall be made without prior
    approval of the Commission till the publication of election results;
  - iii. After the issuance of Election Schedule, the President, Prime Minister, Chief Minister, Governor, Speaker and Deputy Speaker of any assembly, Chairman and Deputy Chairman, of Senate, Federal and Provincial Ministers, Advisors to the Prime Minister or Chief Minister or any other holder of public office shall not visit the area of any local council to announce any development scheme or to canvass or campaign for any candidate or any political party. In case if someone is resident of the district where elections are being held he may visit the district however shall not take part in any kind of political activity.
  - iv. No leave of the Officers and Officials appointed in connection with election on reserved seats will be granted without prior approval of the Commission till the publication of election results. In case leave has already been sanctioned, the officer will not relinquish his charge without approval of the Hon'ble Commission;
  - v. Any holder of public office, who is found to have violated any provision of Election Laws or the instructions issued by the Election Commission, shall be proceeded against as mandated in law;

#### Note:-

- i. The offices of the Election Commission as well as the offices of District Returning Officers and Returning Officers shall remain open on all public holidays if any activity provided in the schedule falls on that day.
- ii. All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hours and the said timing will also be followed on public holidays fixed for any electoral activity of the schedule.
- iii. The respective council hall will be polling station for the election on reserved seats.
- iv. Separate election will be conducted for each category on same day.
- v. Polling Hours will be observed from 08:00 AM to 05:00 PM.
