NOTIFICATION

Islamabad, the 8th November, 2022

No.F.2(15)/2022-LGE-B:- In partial modification of this Commission's Notification of even number dated 25-10-2022 and in exercise of the powers conferred upon it under Article 140(A) and 219(d) of the Constitution of the Islamic Republic of Pakistan, Section 58 of the Elections Act, 2017, Section 16(2) of the Balochistan Local Government Act-2010 read with sub rule 3 rule 9 of the Balochistan Local Government (Election) Rules, 2013 and all other powers enabling it in that behalf, the Election Commission of Pakistan is pleased to revise the election schedule of the special interest (reserved seats) i.e. Women, Peasant, Worker and Non-Muslim of Local Councils (Union Council and urban Council) in 32 Districts of Balochistan Province excluding District Quetta, Lasbela, Hub and MC Huramzai of District Pishin, as per dates given below:-

2. To ensure that elections are conducted honestly, justly, fairly in accordance with law and ensure that the corrupt practices are guarded against, the Election Commission of Pakistan directs that:-

- i. If any person in Government Service misuses his official position in any manner in order to influence results of the elections, he shall be liable to be proceeded against under the Law;
- ii. After issuance of election schedule, no transfers / postings of the Officers and Officials appointed in connection with election shall be made without prior approval of the Commission till the publication of election results;
- iii. After the issuance of Election Schedule, the President, Prime Minister, Chief Minister, Governor, Speaker and Deputy Speaker of any assembly, Chairman and Deputy Chairman, of Senate, Federal and Provincial Ministers, Advisors to the Prime Minister or Chief Minister or any other holder of public office shall not visit the area of any local council to announce any development scheme or to canvass or campaign for any candidate or any political party. In case if someone is resident of the district where elections are being held he may visit the district however shall not take part in any kind of political activity.
- iv. No leave of the Officers and Officials appointed in connection with election will be granted without prior approval of the Commission till the publication of election results. In case leave has already been sanctioned, the officer will not relinquish his charge without approval of the Hon'ble Commission;
- v. Any holder of public office, who is found to have violated any provision of Election Laws or the instructions issued by the Election Commission, shall be proceeded against as mandated in law;

Note:-

- I. The offices of the Election Commission as well as the offices of District Returning Officers and Returning Officers shall remain open on all public holidays if any activity provided in the schedule falls on that day.
- II. All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hours and the said timing will also be followed on public holidays fixed for any electoral activity of the schedule.
- III. Polling Hours will be observed from **08:00 AM to 05:00 PM**.
