No.F.8(2)/2023-Cord(3).---In exercise of powers under section 193 of the Elections Act, 2017 (Act No. XXXIII of 2017), the Election Commission hereby authorizes the District Returning Officer and Returning Officer appointed for the conduct of Bye-election in Thirty-Three (33) Constituencies of National Assembly of Pakistan scheduled to be held on **16th March, 2023** to exercise the powers of the Magistrate of the First Class under the Code of Criminal Procedure, 1898 (Act V of 1898); with immediate effect and until the consolidation and announcement of official results in following constituencies.
