- 2. To ensure that elections to the Local Governments are conducted honestly, justly, fairly in accordance with law and to ensure that the corrupt practices are guarded against, the Election Commission of Pakistan directs that:
  - i. All Executive Authorities in the Federation and in the Province including the Governor, Chief Minister, Ministers, advisors, Special assistance and other setup shall neither announce any development project nor use State Resources in Local Government Elections calculated to influence the elections in favour of a particular candidate;
  - If any person in Government Service misuses his official position in any manner in order to influence results of the elections, he shall be liable to be proceeded against under the law;
  - iii. The Election Officials appointed for the conduct of elections as DRO RO and ARO shall not be transferred / posted till the publication of election results;
  - iv. No leave of the Election Officials will be granted after the issuance of Election Schedule of the Local Government Elections till the publication of election results. In case leave has already been sanctioned, the officer will not relinquish his charge without approval of the Hon'ble Commission.

Note: The offices of the Election Commission as well as the offices of District Returning Officers and Returning Officers shall remain open on all public holidays (including Sunday) if any activity provided in the schedule falls on that day.

All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hours and the said timings will also be followed on public holidays fixed for any electoral activity of the schedule.

Polling Hours will be observed from 08:00 AM to 05:00 PM

Appellate Tribunals may start proceedings of hearing/deciding of appeals simultaneously from 29.01.2025
