### NOTIFICATION

(17) — WHEREAS, sub-section (1) of section 137 of the Elections Act, 2017 read with sub-rule (1) of rule 137 of the Election Rules, 2017 thereof, provides that every Member of an Assembly and Senate shall submit to the Commission, on or before 31<sup>st</sup> December each year, a copy of his statement of assets and liabilities including assets and liabilities of his spouse and dependent children as on the preceding thirtieth day of June on Form-B.
