### NOTIFICATION

**No.F.2(2)/2024-LGE(B)(Vol-I)(3)**: In exercise of the powers conferred upon it under Articles 140A (2) & 218(3) of the Constitution of the Islamic Republic of Pakistan read with Sections-6 & 193 of the Elections Act, 2017, the Election Commission of Pakistan hereby authorizes the Returning Officer / Presiding Officer, appointed for the conduct of Local Government Bye-election to the seat of Chairman, Union Council No.8, Hadkhari, Tahsil Khattan, District Kachhi of Balochistan Province, scheduled to be held on 12.06.2024 to exercise the powers of the Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) for two days i.e 11<sup>th</sup> & 12<sup>th</sup> June, 2024.

2. The aforesaid officer shall exercise the powers of Magistrate First Class under Section-193(a) of the Elections Act, 2017, Chapter-IV of the Balochistan Local Government Act, 2010 except the offence of corrupt practice provided in Section-46 of the ibid-Act. These offences shall be tried summarily in terms of Section-193(b) of Elections Act, 2017, under the provisions of the Code of Criminal Procedure, 1898 (ACT No.V of 1898).
