

Subject: - DE-NOTIFICATION OF MR. FARHAD ULLAH, GENERAL COUNCILOR & MR. FIDA ULLAH, YOUTH COUNCILOR VILLAGE COUNCIL, SARDI KHEL-I UC BAKA KHEL, DISTRICT BANNU.

No.F.28(1)/2023-LGE-KP—In pursuance of the Order dated 22-10-2024 passed by the Election Commission of Pakistan in Case No.4(1)/2024-LGE-KP(M/F) and in exercise of powers conferred upon it under Article 140(A)(2), 219(d) read with Section 78(1)(o) and Section-86 of the Khyber Pakhtunkhwa Local Government Act, 2013 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby de-notifies Mr. Farhad Ullah and Mr. Fida Ullah from the seats of General Councilor and Youth Councilor respectively, from Village Council, Sardi Khel-I, UC Baka Khel, District Bannu, upon their disqualification in above referred case, w.e.f 22-10-2024. Resultantly, the seats of General Councilor and Youth Councilor, VC Sardi Khel-I, UC Baka Khel District Bannu stand vacant from 22-10-2024.


