No.F.2(7)/2022-LGE-B (Vol-IV):- In exercise of the powers conferred upon it under Articles 140A (2) & 218(3) of the Constitution of the Islamic Republic of Pakistan read with Sections-6 & 193 of the Elections Act, 2017, the Election Commission of Pakistan hereby authorizes the District Returning Officer and Returning Officers, appointed for the conduct of Local Government Elections in district Quetta of Balochistan Province, scheduled to be held on 30.11.2023 to exercise the powers of the Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No.V of 1898) with immediate effect till the announcement of official results.

The aforesaid officers shall exercise the powers of Magistrate First Class in respect of all offences under Section-193(a) of the Elections Act, 2017, Chapter-IV of the Balochistan Local Government (Elections) Act, 2010 except the offence of corrupt practice provided in Section-46 of the ibid-Act. These offences shall be tried summarily in terms of Section-193(b) of Elections Act, 2017, under the provisions of the Code of Criminal Procedure, 1898 (ACT No.V of 1898).
