**No.F.2(2)/2025-LGE-B(Vol-I)(1)**: Pursuant to the Order dated 26.05.2025, passed by the Hon'ble High Court of Balochistan, Quetta in C.P.No.(s) 68/2025 and in exercise of the powers conferred upon it under Article 140A(2) of the Constitution of the Islamic Republic of Pakistan, Sections-16(1) & 36 of the Balochistan Local Government Act, 2010 read with Rule-9 of the Balochistan Local Government (Election) Rules, 2013 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby;

- i. Restores its Notification No.F.2(2)/2025-LGE-B dated 04.04.2025 whereby the seats of Chairman and Vice Chairman of Municipal Committee Gandakha, district Usta Muhammad of Balochistan Province were notified vacant as a result of No-confidence Motion.
- ii. Fixes **19-06-2025 (Thursday)** as the date for Local Government Bye-election to the Chairman and Vice Chairman seats of Municipal Committee Gandakha, district Usta Muhammad of Balochistan Province.
