## NOTIFICATION

**No. F.1(1)/2022-Confid (1).**— WHEREAS, sub-section (1) of section 137 of the Elections Act, 2017 read with sub-rule (1) of rule 137 of the Election Rules, 2017 thereof, provides that every Member of an Assembly and Senate shall submit to the Commission, on or before 31<sup>st</sup> December, 2022 each year, a copy of his statement of assets and liabilities including assets and liabilities of his spouse and dependent children as on the preceding thirtieth day of June on Form B.

**AND WHEREAS**, in compliance of sub-section (3) of section 137 of the Act *ibid*, the following Member of **Senate and National Assembly** was ordered to cease to function as Member of the corresponding Assembly vide Notification of even number, dated the 16<sup>th</sup> January, 2023:-


