No.F.8(2)/2024-LGE-KP:— In pursuance of the provisions of Article 140(2) and 218(3) of the Constitution of the Islamic Republic of Pakistan, Section 6 & 193(a) of the Elections Act, 2017 and Section 101 of the Khyber Pakhtunkhwa Local Government Act, 2013 read with Rule-2 & Rule-8(c) of the Khyber Pakhtunkhwa Local Councils (Conduct of Election) Rules, 2021 the Election Commission hereby authorizes the District Returning Officers and Returning Officers appointed for the conduct of 2nd Bye-Election in Khyber Pakhtunkhwa Province, whereby poll shall be held on 20th October, 2024 to exercise the powers of Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) with immediate effect till the announcement of official results.

2. The aforesaid officers shall exercise the powers of Magistrate of the First Class in respect of all offences under Section-193 of the Elections Act, 2017 and Chapter-XIV of the Khyber Pakhtunkhwa Local Government Act, 2013, whereby all such offences shall be tried summarily under the Provisions of the Code of Criminal Procedure, 1898 (Act No. V 1898).
