**Islamabad, the 13<sup>th</sup> August, 2025**

**No.F.1(4)/2025-MW(2).** In pursuance of Article 218(3) read with the Article 220 of Constitution of Islamic Republic of Pakistan, Section-14 read with Section 234 of Elections Act, 2017, Rule-171 of the Election Rules, 2017 and all other powers enabling it in that behalf, the Election Commission is pleased to issue the following Terms of References for the Monitoring Team and District Monitoring Officers for **Bye-Elections in constituencies NA-66 Wazirabad, PP-87 Mianwali-III, & NA-129 Lahore-XIII Punjab Province scheduled to be held on 18<sup>th</sup> September, 2025:**

**TERMS OF REFERENCES**

1. The sub-section-1 of section-234 of the Elections Act-2017 provides that Monitoring Team will report regarding any violation committed by a candidate or a political party of any provision of the Election Act, Election Rules, or the Code of Conduct issued by the Commission in the constituency/area of its jurisdiction as notified to the District Monitoring Officer. For the said purpose Form-M-I will be used.
2. The Monitoring Team will collect information regarding any political activity/rally/Jalsa/event for the purpose of monitoring – from district administration or authority concerned and such authority will be bound to provide information instantly as and when required by the Monitoring teams or Officer Nominated by the Commission.
3. (a) Any violation if noticed, shall be reported in **Form-M-I**, along with evidence(s) to the District Monitoring Officer through the quickest means of communication for decision and if so ordered by the District Monitoring Officer for removal/rectification of such violation (if removable/rectifiable), the orders be complied with by the authority concerned with the assistance of the Focal Person of the Local Administration under security provided by local Police Authorities.  
  
(b) The Local Administration will nominate an officer not below than grade-17, hereinafter called Focal Person Administration, and police authorities will provide reasonable security personnel under the command of a police officer not below the rank of a sub-inspector to carry out the orders of the District Monitoring Officer or Monitoring Team as the case may be.
4. The District Monitoring Officer or Monitoring teams may require any authority to furnish any information and such authority shall be bound to comply with.
5. The monitoring team may inquire/investigate any matter of concern which has any covert or overt purposes of election campaign and directly or indirectly affect election process in any form and for this purpose may involve any such authority (ies) as may deem necessary, such an inquiry/investigation after culmination, if finds someone guilty of violation will be reported to the District Monitoring Officer for orders/decision. On such report the District Monitoring Officer shall decide the matter as provided under sub-sections-3 & 4 of section-234 of the Elections Act-2017.

6. The DMO will maintain record in shape of **Form-M-II** of all the complaints furnished by the monitoring teams on **Form-M-I**. A daily consolidated report of constituency under his/her jurisdiction will be submitted to commission as mentioned under sub-rule 3 of rule-171 of the Election Rules-2017.

7. The DMOs and Monitoring team shall also monitor/ observe Pre-poll, Poll-day and Post poll activities on prescribed observation tools/checklist and submit report along with said checklist.

8. The District Monitoring Officer shall issue directions to any authority, whoever, to abide by the provisions of the Act, Rules or the Code of Conduct issued by the Commission and take such measures for its implementation in letter and spirit.



The Hon'ble Election Commission has been pleased to approve that JPEC (Admn) and REC concerned shall perform duty as Provincial Monitoring Coordinator (PMC) and Regional Monitoring Coordinator (RMC) in their respective jurisdictions, so as to supervise all monitoring activities during the Bye-Elections in NA-66 Wazirabad, PP-87 Mianwali-III, & NA-129 Lahore-XIII, Punjab Province. The PMC and RMC shall be responsible to perform following duties:-

**Provincial Monitoring Coordinator (PMC)/JPEC (Admn)**

- i. To supervise and carry out monitoring of activities pertaining to all elections or non-elections activities as mandated in framework or as per direction of the Hon'ble Commission.
- ii. To coordinate with PEC and ECP Secretariat with regard to appointment of Monitoring Teams during Elections/Bye Elections and other activities where Monitoring will be required.
- iii. To keep close liaison with RMC to ensure smooth functioning of monitoring activities and will be responsible for proper monitoring and conveying instructions of ECP and PEC to them.
- iv. To collect reports on prescribed proforma from RMC and share consolidated report with PEC and ECP.
- v. To coordinate with the Police/Law Enforcement Agencies for provision of necessary security and logistic support to the monitoring teams.
- vi. To ensure establishment and smooth functioning of Provincial Monitoring Control Room (PMCR).

**Regional Monitoring Coordinator (RMC)/REC**

- i. To supervise and carry out monitoring of activities pertaining to all elections or non-elections activities as mandated in framework or as per direction of the Hon'ble Commission.
- ii. To share proposal regarding appointment of Monitoring Team as and when required in their respective region through PMC concerned.
- iii. To coordinate with all relevant stakeholders and conveying instructions of ECP to Monitoring Team.

- iv. To supervise and oversee all monitoring related activities in his region and keep close liaison with the Monitoring Teams of his respective region.
- v. To collect reports on prescribed performa from Monitoring Teams and shall submit the same to the PMC and ECP to avoid unnecessary delay in taking appropriate action.
- vi. To coordinate with DEC in his jurisdiction for proper coordination and guidance of Monitoring Teams regarding their jurisdiction in the limit of constituency.
- vii. To coordinate with the Police/Law Enforcement Agencies for provision of necessary security and logistic support to the monitoring teams.
- viii. To ensure establishment and smooth functioning of Regional Monitoring Control Room (RMCR) and District Monitoring Control Room (DMCR).
