No.F.8(3)/2023-Cord.- In exercise of powers under section 193 of the Elections Act, 2017 (Act No. XXXIII of 2017), the Election Commission hereby authorizes the Presiding Officers appointed for each Polling Station of (6) constituencies of National Assembly of Pakistan, to exercise the powers of a Magistrate of the First Class under the Code of Criminal Procedure, 1898 (Act No.V of 1898) from **29th April, 2023 to 1st May, 2023**, in respect of the offences punishable under section 169 and section 171 punishable under Section 174 of Elections Act, 2017 (Act No. XXXIII of 2017) and may take cognizance of any such offence under Section 190 of the Code of Criminal procedure and shall try it summarily under Chapter XX of the Code.
