#### NOTIFICATION

No.F.3(5)/2023-LGE-S(VoI-VI)(2):— In exercise of the powers conferred upon it under Article 140(A) of the Constitution of Islamic Republic of Pakistan, Sections 219 and 229 of the Elections Act, 2017, Section 34 of the Sindh Local Government Act, 2013 read with Rule-72 of the Sindh Local Councils (Election) Rules, 2015 and all other powers enabling it in that behalf, the Election Commission of Pakistan is pleased to issue election programme for Bye-Elections to the vacant seats of Chairman / Vice Chairman in Town Municipal Corporation, Town Committee, Municipal Committee and District Councils of Sindh province as declared vacant *vide* this Commission's Secretariat Notification No. F.3(5)/2023-LGE-S(VoI-VI)(1) dated 27<sup>th</sup> February, 2025 and call upon the members of the electoral college of concerned Councils to elect the Chairman / Vice Chairman specifying dates for various stages of election as following:

- 2. To ensure that elections to the Local Governments are conducted honestly, justly, fairly in accordance with law and to ensure that the corrupt practices are guarded against, the Election Commission of Pakistan directs that:
  - (i) All Executive Authorities in the Federation and in the Provinces including the Governor, Chief Minister, Ministers, advisors, Special assistance and other setup shall neither announce any development project nor use State Resources in Local Government Elections calculated to influence the elections in favour of a particular candidate;
  - (ii) If any person in Government Service misuses his official position in any manner in order to influence results of the elections, he shall be liable to be proceeded against under the law;
  - (vii) The Election Officials appointed for the conduct of elections as DRO, RO and ARO shall not be **transferred / posted** till the publication of election results;
  - (viii) No leave of the Election Officials will be granted after the issuance of Election Schedule of the Local Government Elections till the publication of election results. In case leave has already been sanctioned, the officer will not relinquish his charge without approval of the Hon'ble Commission.

Note: The offices of the Election Commission as well as the offices of District Returning Officers and Returning Officers shall remain open on all public holidays (including Sunday) if any activity provided in the schedule falls on that day.

Appellate Tribunals may start proceedings of hearing/deciding of appeals simultaneously from 11.03.2025
