No.F.3(5)/2022-LGE-S Vol-VII (II):- Pursuant to the provisions of Articles 140(A) and 219 (d) of the Constitution of the Islamic Republic of Pakistan, Section 228 of the Elections Act, 2017, sub-section (1) of Section 34 of the Sindh Local Government Act, 2013 read with Rule 72 of the Sindh Local Councils (Election) Rules, 2015 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby issues the schedule for Bye-Election of Local Government in Sindh Province on various vacant Direct seats notified by this Commission vide Notification No. F.3(5)/2023-LGE(S) Vol-VII dated 12<sup>th</sup> August, 2025 (Annexure-A) of district Hyderabad, Kambar Shahdakot, Tharparker, Dadu, Khairpur, Shaheed Benazairabad and calls upon the electors of respective Local Councils and Wards of the above mentioned District to elect their representatives and specifies in relation thereto, the following dates:

- 2. To ensure that elections to the Local Governments are conducted honestly, justly, fairly in accordance with law and to ensure that the corrupt practices are guarded against, the Election Commission of Pakistan directs that:
  - (i) All Executive Authorities in the Federation and in the Provinces shall neither announce any development project nor use State Resources in the constituencies where election schedule for conduct of local government by elections has been issued, calculated to influence the elections in favour of a particular candidate;
  - (ii) If any person in Government Service misuses his official position in any manner in order to influence results of the bye-elections, he shall be liable to be proceeded against under the law;
  - (iii) For Taluka/Tehsil/Sub-Division in respect of which election schedule of local government elections has been issued, no transfer / postings of the government officers and officials including those of Autonomous Bodies/Authorities shall be made without prior approval of the Commission till the publication of election results;
  - (iv) No transfers/postings of the Election Officials (DROs, ROs and AROs) or any other election official appointed for the subject election shall be made after the issuance of this schedule till the publication of election results.
  - (v) For Taluka/Tehsil/Sub- Division in respect of which election schedule has been issued, no leave of the government officers and officials including Autonomous Bodies/ Authorities will be granted after the issuance of Election Schedule of the Local Government Elections without prior approval of the Commission till the publication of election results. In case leave has already been sanctioned, the officer will not relinquish his charge without approval of the Hon'ble Commission.

#### NOTE:

- The offices of the Election Commission as well as the offices of District Returning Officers and Returning Officers shall remain open on all public holidays (including Sunday) if any activity provided in the schedule falls on that day.
- ii. All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hours and the said timings will also be followed on public holidays fixed for any electoral activity of the schedule.
- iii. Polling Hours will be observed from 08:00 A.M to 04:00 P.M

iv. Appellate Tribunals already appointed *vide* ECP Notification No. F. 3(5)/2023-LGE-S dated 12<sup>th</sup> October, 2023 will continue to act as Appellate Tribunals for the said bye-elections and may start proceedings of hearing/deciding of appeals simultaneously from 30-08-2025 to 05-09-2025.
