
NOTIFICATION

Islamabad the 10th March, 2023

No.F.8(3)/2023-Cord (3).- In pursuance of Article 218(3) of the Constitution of Islamic Republic of Pakistan read Sub-Section 4 of Section 5 and Section 181 of the Elections Act, 2017, the Election Commission of Pakistan is hereby pleased to direct that:

- (i) No Government or authority shall post or transfer any officer in the districts, where schedule for bye-elections has been issued on 8th March, 2023, till the publication of name of returned candidate.
- (ii) No Government functionary or elected representative(s) including a local government functionary or elected representative shall announce any development scheme for the constituencies, where bye-elections are under process till **30th April, 2023**.
