



ELECTION COMMISSION OF PAKISTAN NOTIFICATION

Islamabad, the 04th December, 2024

No.F.2(12)/2024-Coord.Vol-V(1). Pursuant to the Order dated 20th November, 2024 Passed by the Hon'ble Supreme Court of Pakistan in C.M.A. 10180/2024 and C.A. 1349/2024 titled "Ali Madad Jattak Vs. Mir Muhammad Usman and others", the Election Commission of Pakistan withdraws its Notification No. F. 2(12)/2024-Coord.Vol-IV dated 11th October, 2024. Consequently, ECP's earlier Notification No. F. 2(12)/2024-Coord.Vol-IV(2) dated 3rd October, 2024 regarding re-poll in fifteen (15) Polling Stations of PB-45, Quetta-VIII is restored. However, the fresh date for the conduct of re-poll in fifteen (15) Polling Stations of PB-45, Quetta-VIII is fixed as **19th December, 2024**.

Moreover, the ECP's Notification No. F. 2(12)/2024-Coord.Vol-- dated 26th September, 2024 is also restored, whereby Notification of Ali Madad, returned candidate from PB-45 Quetta-VIII has been suspended. Resultantly, Ali Madad, returned candidate from Constituency PB-45, Quetta-VIII is de-notified.


