Terms & Conditions

- 1. All the Tenders, complete in all respect, should be submitted on EPADS as well as in the office of the Deputy Director (Admn) O/o the PEC Balochistan (in hard shape) on or before tender's opening date i.e. 14th April, 2025 (Monday) at 11:00 AM which will be opened on the same date at 12:30 PM in the presence of Tender Committee and bidders as may be present. E-mailed or faxed bid received in this office will not be accepted.
- 2. Tender documents containing detailed terms and conditions can be obtained on written request from the office of Provincial Election Commissioner, Zarghoon Road, Quetta latest by 11th April 2025 (Friday) till 03:00 PM against the prescribed fee of Rs.1,000/-(Rupees One Thousand only) non-refundable, on any working day during office hours.
- 3. The bidder shall quote rate for each item. No firm can change the rates after opening the bids.
- 4. Authorized dealers / firms will attach snaps of hardware, furniture & machinery items, whos rates have been quoted in tender notice. Approval of rates will be subject to approval of quality of samples by the tender and technical committees.
- 5. The bidder will not set forth their own terms and conditions contradictory to the terms and conditions given in the documents or PPRA rules. In the event of arbitration as a result of conflicting, the terms and conditions given in the tender documents or PPRA rules will prevail.
- 6. Tendering will be conducted in Single Stage-Two Envelopes methods. i.e. a single envelope containing two separate envelopes marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion.
- 7. The company should have their support / services /office in Quetta and or in other big cities of Balochistan.
- 8. The Company should have minimum 05 years' experience in the relevant field.
- 9. The bidder should have authorized OEM Partner / Dealer certificate from principal. (Preferable Gold Partner) & ISO certification.
- 10. Bidders should submit a "Certificate" that the company has never been declared blacklisted or defaulter by any Federal & Provincial departments of Government of Pakistan.
- 11. Price should be quoted in Pak Rupees both in words and figures.
- 12. The Price quoted should be final and clearly written/typed and without any ambiguity. Rates/bids submitted will be valid for a period of six months.
- 13. The price should include all the government taxes (Including GST/BST if applicable),

- 14. The rates or prices shall be entered against each item in the BOQ.
- 15. The bidder shall furnish a bid security/earnest money equivalent to 5% of each item separately of the total value of the bid in the form of bank draft or pay order issued by the scheduled bank of Pakistan in favor of **DDO**, office of Provincial Election Commissioner, Balochistan which shall be submitted by hand physically or post to the office of Provincial Election Commissioner, Zarghoon Road, Quetta before deadline.
 - 16. The successful firm will complete the delivery / supply of the items within a period of 45 days after execution of agreement.
 - 17. Payment will be made upon successful installation / commissioning or complete supply / delivery of relevant items.
 - 18. The procuring agency reserves the rights to increase or decrease the number of items being purchased at any stage as per requirement.
