

ELECTION COMMISSION OF PAKISTAN

NOTIFICATION

Islamabad, the 25th September, 2023.

No.F.3(5)/2022-LGE-S:— In exercise of the powers conferred upon it under Article 140(A) of the Constitution of Islamic Republic of Pakistan, Sections 219 and 229 of the Elections Act, 2017, sub-section (1) of Section 34 & sub sections (2) and (5) of Section 18 of the Sindh Local Government Act, 2013 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby issues schedule for filling up the vacant indirect seats in Union Committees and Union Councils of district Jacobabad, Kashmore, Shikarpur, Larkana, Kamber Shahdadkot, Ghotki, Sukkur, Khairpur, Naushero Feroze, Shaheed Benazirabad, Sanghar, Mirpurkhas, Tharparker, Tando Allahyar, Hyderabad, Tando Muhammad Khan, Jamshoro, Dadu, Badin, Sujawal, Thatta, Malir, Korangi Karachi, Karachi East, Karachi West, Karachi South, Karachi Central and Keamari Karachi, which have been notified by the Commission vide notification No. F.3(5)/2023-LGE(S) dated 25th September 2023, and calls upon the members of the electoral college of concerned Councils and Committees to elect the members against reserved seats of Women, Youth, Non-Muslims, and Labourers/Peasants, and specifies in relation thereto, the following dates:

2. To ensure that elections to the Local Governments are conducted honestly, justly, fairly in accordance with law and to ensure that the corrupt practices are guarded against, the Election Commission of Pakistan directs that:

- (i) *All Executive Authorities in the Federation and in the Provinces including the Governor, caretaker Chief Minister, Ministers, advisors, Special assistance and other caretaker setup shall **neither announce any development project nor use State Resources** in Local Government Elections calculated to influence the elections in favour of a particular candidate;*
- (ii) *If any person in Government Service misuses his official position in any manner in order to influence results of the elections, he shall be liable to be proceeded against under the law;*
- (iii) *The Election Officials appointed for the conduct of elections as DRO and RO shall not be **transferred / posted** till the publication of election results;*
- (iv) ***No leave of the Election Officials** will be granted after the issuance of Election Schedule of the Local Government Elections till the publication of election results. In case leave has already been sanctioned, the officer will not relinquish his charge without approval of the Hon'ble Commission.*

Note: The offices of the Election Commission as well as the offices of District Returning Officers and Returning Officers shall remain open on all public holidays (including Sunday) if any activity provided in the schedule falls on that day.

All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hours and the said timings will also be followed on public holidays fixed for any electoral activity of the schedule.

Polling Hours will be observed from **08:00 A.M. to 05:00 P.M.**

Appellate Tribunals may start proceedings of hearing/deciding of appeals simultaneously from 10-10-2023.
