No.F.2(2)/2025-LGE-B(Vol-V)(3):- In exercise of powers under Section 193 of the Elections Act, 2017 (Act No. XXXIII of 2017), the Election Commission hereby authorizes the Returning Officers / Presiding Officers appointed for the conduct of Local Government Bye-elections to the vacant seats of Chairman / Vice Chairman of Union Council No.28 Chalgari, district Kachhi and Chairman seat of District Council, Sohbat Pur of Balochistan Province to exercise the powers of a Magistrate of the First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) from **3rd to 4th February, 2026**, in respect of the offences defined in Sections 169 and 171, punishable under Section 174 of Elections Act, 2017 (Act No. XXXIII of 2017); and may take cognizance of any such offence under Section 190 of the Code of Criminal Procedure; and shall try it summarily under Chapter XX of the Code.
