No.F.8(2)/2024-LGE-KP:- In pursuance of the provisions of Articles 140(2) and 218 of the Constitution of the Islamic Republic of Pakistan, Section 6 (1) & 193 of Elections Act, 2017, Section-101 of the Khyber Pakhtunkhwa Local Government Act, 2013 read with Rule-2 of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules, 2021, the Election Commission hereby authorizes the Presiding Officers appointed at each polling station for the conduct of Local Government election to the vacant seat of Chairman, Tehsil Council Jamrud, District Khyber in Khyber Pakhtunkhwa (whereby poll shall be held on 25th September, 2024) to exercise the powers of Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No .V of 1898) from 24th to 26th September, 2024.

The aforesaid officers shall exercise the powers of Magistrate First Class in respect of offences under Section-193(a)(b) of the Elections Act, 2017 and Chapter-XIV of the Khyber Pakhtunkhwa Local Government Act, 2013 and, all such offences shall be tried summarily under the Provisions of the Code of Criminal Procedure, 1898(Act No.V of 1898).
