



# **ELECTION COMMISSION OF PAKISTAN**

## **NOTIFICATION**

Islamabad, the 14<sup>th</sup> March, 2024

**F.No.3(1)/2024-Coord.(M/F):-** In pursuance of Section 107 of the Elections Act, 2017, read with clause (3) of Article 59 and clause (3) of Article 224 of the Constitution of the Islamic Republic of Pakistan and the Senate (Election of Members from the Federal Capital) Order, 2018 (P.O.No.1 of 2018), the Election Commission of Pakistan hereby calls upon the Members of National Assembly to elect Members of the Senate **against one General seat and one seat for Technocrats including Ulema from the Federal Capital**. The Election Commission of Pakistan also calls upon the Members of **Provincial Assemblies of the Punjab, Sindh, Khyber Pakhtunkhwa and Balochistan** Provinces to elect Members against seven General seats, two Women seats and two seats for Technocrats including Ulema from each province and one seat for non-Muslims each from Punjab and Sindh provinces, which have become vacant after expiration of the term of the incumbent members on 11<sup>th</sup> March, 2024 and fixes, in relation thereto, the following stages and dates:
