No.F.1(3)/2024-LGE-ICT:- WHEREAS, the Election Commission of Pakistan under Article 222(b) of the Constitution of the Islamic Republic of Pakistan and Sections- 17 & 221 of the Elections Act, 2017 read with Sections-6 & 7 of the Islamabad Capital Territory Local Government Act, 2015, is charged with the duty to delimit the constituencies of the Local Government Institutions in Islamabad Capital Territory (ICT).

WHEREAS the Election Commission of Pakistan has issued schedule for carrying out delimitation of Union Councils and corresponding Wards in Union Councils in the Federal Capital vide Notification bearing No.F.1(3)/2024-LGE-ICT(1) dated 31-05-2024.

AND WHEREAS, Delimitation of Union Councils /Wards is required to be carried out giving due regard to the existing boundaries of administrative units such as District, Tehsil etc, tiers and extents of local areas. Accordingly any change in limits of these units, tiers and extents of local area(s) when proceedings of delimitation are under way, shall hamper the smooth proceedings.

NOW THEREFORE, in exercise of the powers conferred upon it under Article 218(3) of the Constitution of the Islamic Republic of Pakistan read with Section-221 of the Elections Act, 2017 and all other powers enabling it in that behalf, the Election Commission of Pakistan is pleased to direct that boundaries of existing administrative units and local area (s) shall stand freezed forthwith and no change in the boundaries of aforementioned administrative units, tiers and extents of local area(s) shall be made till the culmination of the delimitation process in Islamabad Capital Territory.
