3. Bidders should mention per unit price (inclusive of all taxes) for each item of group for which tender documents are to be submitted.
4. The successful bidder will be bound to provide items on quoted rates.
5. Tenders may be submitted along with 5% earnest money of bid amount in shape of call deposit in the name of DDO, Election Commission of Pakistan, to the undersigned before 17-04-2025 at 12:00 P.M.
6. Documentary proof of ISO Certificate, General Sales Tax, SECP Certificate and Income Tax Registration should be sent along with tender.
7. Income tax and other taxes will be deducted as per Govt. instruction and applicable rate.
8. Incomplete tenders will not be considered.
9. Firm will be responsible to supply the items to the office at their own expenses.
