Term of References (ToRs)

- i. RMC shall prepare and share proposals regarding appointments of District Monitoring Teams in their respective divisions through PMC concerned.
- ii. RMC shall oversee all monitoring related activities in his region and keep close liaison with the concerned DMOs and Monitoring Teams.
- iii. RMC shall be responsible for conveying instructions of ECP to them.
- iv. RMC shall collect report on Form M-II from DMOs and shall submit the same to the ECP duly consolidated on Form M-III under intimation to PMC.
- v. RMC shall convey any information about violation of Code of Conduct received by him from any source to DMO concerned for further action.
- vi. RMC shall ensure through DEC concerned to communicate the territorial jurisdictions of the Monitoring Teams.
- vii. RMC shall ensure establishment and smooth functioning of District Election Monitoring Control Room (DEMCR).
