**No.F.2(2)/2025-LGE-B(Vol-V)(3):-** In exercise of powers under Section 193 of the Elections Act, 2017 (Act No. XXXIII of 2017), the Election Commission hereby authorizes the Returning Officers / Presiding Officers appointed for the conduct of Local Government Bye-elections to the vacant seats of Chairmen, Union Councils No.3 & 6 of district Musakhel, Union Council No.12 of district Kalat and District Council Gwadar, District Gwadar of Balochistan province to exercise the powers of a Magistrate of the First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) from **16<sup>th</sup> to 17<sup>th</sup> December, 2025**, in respect of the offences defined in Sections 169 and 171, punishable under Section 174 of Elections Act, 2017 (Act No. XXXIII of 2017); and may take cognizance of any such offence under Section 190 of the Code of Criminal Procedure; and shall try it summarily under Chapter XX of the Code.
