No.F.3(1)/2022-LGE-S Vol-IX:- In partial modification to this Commission's Notification No.F.3(1)/2022-LGE-S Vol-VIII dated 10th October, 2024 and in pursuance of Section 140(1)(b) of the Elections Act, 2017, read with section 47(1) of the 'Sindh Local Government Act, 2013 and Rule 63(1) of the 'Sindh Local Government (Election) Rules, 2015', Election Commission of Pakistan, in consultation with the Hon'ble Acting Chief Justice of the High Court of Sindh, Karachi, is pleased to appoint **Mr. Gul Zamir Solangi**, Additional District & Sessions Judge, Karachi East as Election Tribunal for Karachi East and Karachi Korangi in place of **Mr. Shahid Ali Memon**, Additional District & Sessions Judge, Karachi East (who has now been transferred and posted as Additional District & Sessions Judge Shahdadpur). The Learned Additional District & Session Judge, Karachi East Mr. Gul Zamir Solangi shall try and decide election petitions pertaining to the 2nd Phase Local Government Elections, 2022 held on 15th January, 2023, in respect of all categories of seats. In case, the specified/nominated Judge is transferred, pending and fresh election petitions shall be tried and disposed of by his successors-in-office. Likewise, the same/appointed Judge or their successors-in-office shall try and decide the election petitions arising out of succeeding bye-elections in future, if any.

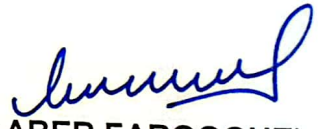
