NOTIFICATION

No. F.1(1)/2022-Confid (10).— WHEREAS, sub-section (1) of section 137 of the Elections Act, 2017 read with sub-rule (1) of rule 137 of the Election Rules, 2017 thereof, provides that every Member of an Assembly and Senate shall submit to the Commission, on or before 31st December each year, a copy of his statement of assets and liabilities including assets and liabilities of his spouse and dependent children as on the preceding thirtieth day of June on Form B.

AND WHEREAS, in compliance of sub-section (3) of section 137 of the Act *ibid*, the following Members of **National Assembly** and **Provincial Assembly Sindh** were ordered to cease to function as Member of the corresponding Assembly *vide* Notification of even number, dated the 16th January, 2023:-


