No. F.3(1)/2022-LGE-S Vol-VIII:- In partial modification of Commission's Notification No.F.20(1)/2022-Law dated 10th May, 2023 and in pursuance of Section 140(1)(b) of the Elections Act, 2017, read with section 47(1) of the 'Sindh Local Government Act, 2013 and Rule 63(1) of the 'Sindh Local Government (Election) Rules, 2015', Election Commission of Pakistan, in consultation with the Hon'ble Chief Justice of the High Court of Sindh, Karachi, is pleased to appoint Mr. Shahid Ali Memon, Additional District & Sessions Judge, Karachi East as Election Tribunal for Karachi East in place of Mr. Ghulam Mustafa Laghari, Additional District & Sessions Judge Karachi East (who has now been transferred and posted as Additional District & Sessions Judge Karachi Central). Likewise, the same/appointed judge or their successors-in-office shall try and dispose of the election petitions emergent of succeeding bye-elections in future, if any.
