Islamabad, the 10th March, 2024

F.No.3(1)/2024-Coord.(M/F).- In pursuance of Section 105 of the Elections Act, 2017, read with clause (3) of Article 224 of the Constitution of the Islamic Republic of Pakistan, the Election Commission of Pakistan hereby appoints the following Returning Officers to conduct of Senate Elections to fill one General seat and one seat for Technocrats including Ulema from the Federal Capital. The Election Commission of Pakistan also calls upon the Members of Provincial Assemblies of the Punjab, Sindh, Khyber Pakhtunkhwa and Balochistan Provinces to elect Members against seven General seats, two Women seats and two seats for Technocrats including Ulema from each province and one seat for non-Muslims each from Punjab and Sindh provinces, which are going to be vacant after expiration of term of incumbent Senators on 11th March, 2024:
