No.F.2(12)/2024-Coord(1)-. Pursuant to the Order dated 18th March, 2024 passed by the Hon'ble Supreme Court of Pakistan in Civil Misc. Applications No.2150 and 2151 of 2024 in Civil Appeals No.Nil of 2024. The Election Commission of Pakistan hereby withdraws its Notification No.F.2(12)/2024-Coord dated 16th March, 2024 regarding re-poll in six (6) polling stations of PB-50 Killa Abdullah and Notification dated 15th March, 2024 of Returning Officer for conduct of re-poll.

2. Further, pursuant to the above said Order of Hon'ble Supreme Court of Pakistan, re-poll in entire constituency of PB-50 Killa Abdullah shall be held on **21st April, 2024** and the Election Commission of Pakistan under Section 50 and 51 of the Elections Act, 2017 hereby appoints Zakir Ali, Deputy Commissioner Killa Abdullah as District Retuning Officer, Zaheer Ahmed Assistant Commissioner Gulistan as Returning Officer and Abdul Mateen Assistant District Education Officer Dobandi and Anwar Ali Naib Tehsildar Killa Abdullah as Assistant Returning Officers for PB-50 Killa Abdullah.

3. Moreover, in light of said Order of Hon'ble Supreme Court of Pakistan, the Notification No.F.2(12)/2024-Cord, No.F.2(12)/2024-Cord.M/F, dated 13th February, 2024 regarding declaring Mr. Zamarak Khan as returned candidate from constituency No. PB-50 Killa Abdullah are also withdrawn.
