The instant Constitution Petition has been antedated for today while accepting CMA No.452/2023 on 02.03.2023 filed by contesting respondent No.4.

Today, we have heard learned counsel for the petitioner, Legal Advisor Election Commission of Pakistan (ECP) assisted by Mr. Shehzad Aslam, Law Officer, ECP and learned counsel for respondent No.4 at length.

For the reasons to be recorded later on, the Constitution Petition is accepted. The order of Returning Officer regarding acceptance of nomination papers of respondent No.4 for the seat of worker in Union Council 16 (Tehsil Sonmiani District Hub) as well as order dated 10.02.2023 passed by learned Additional District Judge-II, Hub/Appellate Tribunal in Election Appeal No.01/2023 are set aside. The nomination papers of respondent No.4 for the seat of worker in Union Council 16 (Tehsil Sonmiani District Hub) are hereby rejected. Respondent Nos.2 and 3 are directed to delete the name of respondent No.4 from the list of validly nominated/contesting candidates for the seat of worker in Union Council 16 (Tehsil Sonmiani District Hub).

The earlier interim order dated 28.02.2023 passed by this Court stands recalled.
