### NOTIFICATION

**No. F. 3(6)/2023-LGE-S:** In pursuance of Section-140(2)(b) of the Elections Act, 2017, Section-47(1) of the Sindh Local Government Act, 2013 read with Rule-63 of the Sindh Local Councils (Election) Rules, 2015, the Election Commission of Pakistan, in consultation with the Hon'ble Chief Justice of the High Court of Sindh, Karachi, hereby appoints all the District & Sessions Judges in Sindh province to act as Election Tribunal in their respective Districts, for trial and disposal of election petitions pertaining to the elections of reserved seats in all local councils of Sindh Province and all subsequent bye elections. The District & Sessions Judges of Sindh Province shall also act as Election Tribunal in their respective Districts, for trial and disposal of election petitions arising out of the elections to the seats of heads of local councils i.e. Mayors and Deputy Mayors, Chairmen and Vice Chairmen in Municipal Corporations, Town Municipal Corporations, Municipal Committees, Town Committees and District Councils and all subsequent bye-elections. The District & Sessions Judge, Karachi South is also appointed as Election Tribunal for trial and disposal of election petitions relating to the elections of reserved seats as well as elections of Mayor and Deputy Mayor of Karachi Metropolitan Corporation and all subsequent bye-elections of reserved seats and Mayor and Deputy Mayor in Karachi Metropolitan Corporation.
