No.F.8(2)/2021-LGE-KP(Vol-II):— In pursuance of the provisions of Articles 140A(2) and 218 (3) of the Constitution of the Islamic Republic of Pakistan, Section-06 & 193(a)(b) of the Elections Act, 2017 and Section-101 of the Khyber Pakhtunkhwa Local Government Act, 2013 read with Rule-2 of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules, 2021 the Election Commission hereby authorizes the Presiding Officers appointed for each Polling Station for the conduct of Local Government Bye-Election to the seats of Chairmen Tehsil Council Havelian Abbottabad and Mathra Peshawar, whereby poll will be held on **6th August, 2023** to exercise the powers of Magistrate of the First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) from **5th to 7th August, 2023**.

2. The aforesaid officers shall exercise the powers of Magistrate of the First Class in respect of all offences under Section-193(a)(b) of the Elections Act, 2017 and Chapter-XIV of the Khyber Pakhtunkhwa Local Government Act, 2013, whereby all such offences shall be tried summarily under the Provisions of the Code of Criminal Procedure, 1898 (Act No. V 1898).
