## NOTIFICATION

**No. F. 13(1)/2021-LGE-KP :-** In pursuance of Section 140 (2)(a) of the Elections Act, 2017, Election Commission of Pakistan, in consultation with the Hon'ble Chief Justice of the Lahore High Court, Lahore, is pleased to appoint the following Hon'ble judges of the Lahore High Court to act as Election Tribunal in area specified against their names for the trial and disposal of election petitions pertinent to the bye-elections held in 2022 for National and Provincial Assembly Constituencies. In case, any of the specified/nominated judges is transferred, pending and fresh election petitions shall be tried and disposed of by his successors-in-office. Likewise, the same/appointed judges or their successor-in-office shall try and dispose of the election petitions emergent of succeeding bye-elections in future, if any:-
