TERMS OF REFERENCES

- 1. The DMO and Monitoring Officers before assuming responsibilities shall take oath from District Returning Officer, Quetta on Form-27 in accordance with section-56 of Elections Act, under confirmation to this Commission's Secretariat through PEC, Balochistan.
- 2. The sub-section-1 of section-234 of the Elections Act-2017 provides that Monitoring Team will report regarding any violation committed by a candidate or a political party of any provision of the Election Act, Election Rules, or the Code of Conduct issued by the Commission in the constituency/area of its jurisdiction as notified to the District Monitoring Officer. For the said purpose Form-M-I will be used.
- 3. The Monitoring Team will collect information regarding any political activity/rally/Jalsa/event for the purpose of monitoring from district administration or authority concerned and such authority will be bound to provide information instantly as and when required by the Monitoring teams or Officer Nominated by the Commission.
- 4. (a) Any violation if noticed, shall be reported in Form-M-I, along with evidence(s) to the District Monitoring Officer through the quickest means of communication for decision and if so ordered by the District Monitoring Officer for removal/rectification of such violation (if removable/rectifiable), the orders be complied with by the authority concerned with the assistance of the Focal Person of the Local Administration under security provided by local Police Authorities.
- (b) The Local Administration will nominate an officer not below than grade-17, hereinafter called Focal Person Administration, and police authorities will provide reasonable security personnel under the command of a police officer not below the rank of a sub-inspector to carry out the orders of the District Monitoring Officer or Monitoring Team as the case may be.
- 5. The District Monitoring Officer or Monitoring teams may require any authority to furnish any information and such authority shall be bound to comply with.
- 6. The monitoring team may inquire/investigate any matter of concern which has any covert or overt purposes of election campaign and directly or indirectly affect election process in any form and for this purpose may involve any such authority (ies) as may deem necessary, such an inquiry/investigation after culmination, if finds someone guilty of violation will be reported to the District Monitoring Officer for orders/decision. On such report the District Monitoring Officer shall decide the matter as provided under sub-sections-3 & 4 of section-234 of the Elections Act-2017.



- 7. The DMO will maintain record in shape of Form-M-II of all the complaints furnished by the monitoring teams on Form-M-I. A daily consolidated report of constituency under his/her jurisdiction will be submitted to commission as mentioned under sub-rule 3 of rule-171 of the Election Rules-2017.
- 8. The DMOs and Monitoring team shall also monitor/ observe Pre-poll, Poll-day and Post poll activities on prescribed observation tools/checklist and submit report along with said checklist.
- 9. The District Monitoring Officer shall issue directions to any authority, whoever, to abide by the provisions of the Act, Rules or the Code of Conduct issued by the Commission and take such measures for its implementation in letter and spirit.
