

**NOTIFICATION**

**F.No.4(4)/2022-MW(Vol-III)-WHEREAS**, the Election Commission of Pakistan in exercise of its powers vested under Section-234 of the Elections Act, 2017, in connection with General Elections-2024, had constituted monitoring teams for each constituency and appointed District Monitoring Officers for each district, for monitoring the election campaign of political parties and candidates; and accordingly, the District Monitoring Officer was authorized by law to probe the reports and complaints of violations of Code of Conduct, issued under Section-233 *ibid*, and proceed against violators, including imposition of fine not exceeding Rs.50,000/=;

2. **WHEREAS**, during the entire process of General Elections-2024, the District Monitoring Officers, acting upon reports and complaints, imposed overall 301 fines upon individuals/candidates for different description of violations, after show-causing them and service of prior notices in each individual case. The fines so imposed was immediately required to be deposited by the respective candidates/individuals into the Government Treasury under the head "**C02166-Receipts of Election Commission of Pakistan under the Elections, 2017**" but despite elapsing of considerable period of time and service of reminders and time-bound notices, overall 68 individuals/candidates, penalized for various violations, have so far failed to deposit the outstanding amount of fine into the Government Treasury;

3. **AND WHEREAS**, lastly, as per time-bound notices issued on 3<sup>rd</sup> July, 2025, the defaulting individuals/candidates were asked to deposit the outstanding fine into the Government Treasury but *prima facie* in sheer defiance of the direction of the Election Commission they have utterly failed to clear the perpetual default on their part, warranting to be proceeded against further under the law;

4. **NOW, THEREFORE**, the Election Commission has decided to declare 49 individuals/candidates listed here-under as defaulters of the Government dues and as provided by the Rule-171(3B) of the Election Rules, 2017, the fines so imposed upon them by District Monitoring Officers shall be recovered from them under Section-80 of the Land Revenue Act, 1967 through the respective Land Revenue Collectors, to be deposited into the Government Treasury under the head, "**C02166-Receipts of Election Commission of Pakistan under the Elections, 2017**", under intimation to the Election Commission's Secretariat through respective District Election Commissioners:
