No.F.2(2)/2025-LGE-B(Vol-IV):- In exercise of the powers conferred upon it under Article 140(A)(2) of the Constitution of the Islamic Republic of Pakistan, Section 219 of the Elections Act, 2017, Section 16 of the Balochistan Local Government Act, 2010 read with Rule-9(1) of the Balochistan Local Government (Election) Rules, 2013 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby calls upon the voters of respective constituencies/ wards to elect their representatives to the General seats of Urban Union Councils in Quetta district of Balochistan Province and in connection therewith appoints the following dates of various activities of elections.

- 2. To ensure that elections to the Local Government are conducted honestly, yo justly, fairly in accordance with law and to ensure that the corrupt practices are guarded against, the Election Commission of Pakistan directs that;
 - i. If any person in Government Service misuses his official position in any manner in order to influence results of the elections, he shall be liable to be proceeded against under the Law:
 - ii. No transfers / postings of the Officers and Officials in district Quetta shall be made without prior approval of the Commission till the publication of election results:
 - iii. After the issuance of Election Schedule, the President, Prime Minister, Chairman / Deputy Chairman Senate, Speaker, Deputy Speaker of an Assembly, Federal Minister, Ministers of States, Governors, Chief Ministers, Provincial Ministers and Advisors to the Prime Minister and the Chief Minister, Chairmen / Vice Chairmen, shall not participate in election campaign. However, members of any Assembly, Senate and Local Government are allowed to participate in the election campaign. They will strictly abide by the code of conduct, direction, instructions and regulations issued by the Election Commission of Pakistan and violations thereof shall entail legal consequences.
 - iv. No Government functionary or elected representative including a local government functionary or elected representative shall announce any development scheme in district Quetta till the poll day.
 - v. No leave of the Officers and Officials appointed in connection with Local Government elections in district Quetta will be granted without prior approval of the Commission till the publication of election results. In case leave has already been sanctioned, the officer will not relinquish his charge without approval of the Hon'ble Commission;

Note:-

- The offices of the Election Commission as well as the offices of District Returning Officers and Returning Officers shall remain open on all public holidays if any activity provided in the schedule falls on that day.
- ii. All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hours and the said timing will also be followed on public holidays fixed for any electoral activity of the schedule.
- iii. Polling Hours will be observed from 08:00 AM to 04:00 PM.
