No.F.8(7)/2025-Coord-M/F(4).- In pursuance of Article 218(3) of the Constitution of Islamic Republic of Pakistan read with Sub-Section (4) of Section 5 and Section 181 of the Elections Act, 2017, the Election Commission of Pakistan is hereby pleased to direct that:

- (i) No Government or authority shall post or transfer any officer in the district, where schedule for bye-election in constituencies No. **NA-143 Sahiwal-III, NA-185, D.G. Khan-II** and **PP-203 Sahiwal-VI** have been issued on **20th August, 2025**, till the publication of name of returned candidate.
- (ii) No Government functionary or elected representative(s) including a local government functionary or elected representative shall announce any development scheme for the constituencies, where bye-election is under process till **5th October, 2025**.
