## NOTIFICATION

**No.F.2(2)/2024-LGE-B(3):-** In exercise of the powers conferred upon it under Articles 140A (2) & 218(3) of the Constitution of the Islamic Republic of Pakistan read with Sections-6 & 193 of the Elections Act, 2017, the Election Commission of Pakistan hereby authorizes the Returning Officers /Presiding Officers, appointed for the conduct of Local Government Bye-election to the seats of Chairmen of District Council Jaffarabad & Municipal Committee Sui, Dera Bugti and Vice Chairman seat of District Council Harnai of Balochistan Province, scheduled to be held on 22-05-2024 to exercise the powers of the Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) for two days i.e 21<sup>st</sup> & 22<sup>nd</sup> May, 2024.

2. The aforesaid officers shall exercise the powers of Magistrate First Class under Section-193(a) of the Elections Act, 2017, Chapter-IV of the Balochistan Local Government Act, 2010 except the offence of corrupt practice provided in Section-46 of the ibid-Act. These offences shall be tried summarily in terms of Section-193(b) of Elections Act, 2017, under the provisions of the Code of Criminal Procedure, 1898 (ACT No.V of 1898).
