Sikandar Sultan Raja, Chairman—In terms of Article 51(3)(4) of the Constitution of the Islamic Republic of Pakistan, 1973 (“Constitution”) as per 25th Constitutional Amendment, the National Assembly consists of 266 General seats, 60 seats reserved for women and 10 seats for Non-Muslims and the Provincial Assembly of Punjab consists of 297 General seats, 66 seats reserved for women and 08 seats for Non-Muslims. The Pakistan Bureau of Statistics Officially published the final results of the 07th Digital Population and Housing Census-2023 on 7th August, 2023 and the Election Commission of Pakistan (hereinafter referred as “ECP”) in pursuance of the provisions of Article 218 (3) of the Constitution read with Section 17 of the Elections, Act, 2017 read with Rule 7 of the Election Rules, 2017 initiated the delimitation exercise in accordance with the number of seats in the National as well as Provincial Assemblies as specified in Article 51 and 106 of the Constitution. Accordingly, five (05) delimitation committees were constituted for the preparation of draft proposals of delimitation of constituencies of the National and Provincial Assemblies vide Office Order No.1/2023 dated. 17th August, 2023. In pursuance of Section 21 of the Elections Act, 2017 read with Rule 11 of the Elections Rules, 2017, preliminary report of delimitation committees was published by the ECP in respect of National Assembly and the Provincial Assemblies of the provinces of Khyber Pakhtunkhwa, Punjab, Sindh, Balochistan and Islamabad Capital Territory and invited representations and suggestions thereon for accessible delimitation process so that the political parties and general public be given fair chance to participate in the electoral process. ECP received fifty two (52) representations in respect of National & Provincial Assembly constituencies of



District Lahore. All the representations were decided by the Commission vide order Dated 26-11-2023.

2. The petitioner No.01 Muhammad Israeel has challenged the above order of this Commission before the Hon'ble Lahore High Court Lahore through Writ petition No.8043/2023 with certain amended proposals of delimitation regarding NA-120, NA-122, NA-123 and NA-125. The Hon'ble Court on 08-12-2023 remanded the matter to the Commission with the direction to decide the Petition in accordance with law after hearing all the concerned with in three days. The written order of the Hon'ble High Court is still awaited, however, order was passed in the Court room in presence of the representatives of the Commission.

3. In compliance of the above order of Hon'ble Lahore High Court, the Commission issued notices to all the petitioners/objectors who had earlier filed the representation including Mr. Muhammad Israeel for appearance on 11-12-2023 before the Commission.

4. On the date of hearing i.e 11-12-2023, Respondents No.2 & 3 Mr. Karamat Ali & others and Muhammad Akmal, appeared and also informed the Commission that their Writ Petitions were also fixed today before the Hon'ble Islamabad High Court and the Hon'ble Court referred the matters to the Commission for decision as the Commission has already issued notices to all the objectors in the petition of Mr. Israeel, remanded by the Hon'ble Lahore High Court Lahore.

Facts of the representations of petitioner Nos 1 to 15:

5 The petitioner No.01 namely Mr. Muhammad Israeel through his counsel Mr. Taimoor Aslam Khan Advocate has given amended proposal in his writ petition No.8043/2023, regarding NA-120, 122, 123 and 125 as compared to his earlier proposal given during petition against preliminary delimitation which was partially accepted vide Commissions order dated 26-11-2023. In addition to his previous proposal following is the proposal of the petitioner in respect of NA-120, 122, 123 and 125:-

PROPOSAL OF NA-123 LAHORE

Exclusion:

Circle No.7 (Defence phase 5), 8(Defence Phase 2) &9 (small industry Society-Alfalah Town Bedian Road) of Charge No.18817



Walton Cantonment having Population of 66,827 Excluded from NA-123 and included in NA-122 since the Cantonment's main Administration unit is located thereunder.

Inclusion;

- i Circle Nos 4 and 9 of charge No. 18602 of Lahore Cantt having population of 33,297 has been excluded from NA-120 and included in NA-123.
- ii Circle No.6 of charge no.18601 of Tehsil Cantt having population of 18,890 has been excluded from NA-120 and included in NA-123.
- iii Charge No 26105 of Tehsil Raiwind having population of 16,857 has been excluded from NA-125 and included in NA-123.
- iv Charge No 18703 of Tehsil Cantt having population 48,547 has been excluded from NA-122 and included in NA-120.

6 In addition to the above proposal, the Counsel for the petitioner has highlighted the issue of Walton Cantonment. The petitioner elaborated that Walton Cantonment is one of the biggest cantonment in the country which is distributed between the constituencies whereas petitioner in his proposal has suggested to include three circles of charge No.11 of Walton cantonment in NA-122. Through the proposal of the petitioner the population of the constituencies will remain within the prescribed population quota and it will be more compact and convenient for the general public.

7 The petitioners No.02 namely Mr. Muhammad Younas Adeel/ Karamat Ali and other through their counsel Mr. Taimoor Aslam Khan Advocate have initially given the following proposal through their representation which was partially accepted. The previous proposal in respect of the National Assembly constituencies i.e. NA-120, NA-121, NA-122, NA-123, NA-124, NA-125, NA-127 and NA-128 is given below:-

PROPOSAL OF NA-120 LAHORE

- i. Circle No.1, 2 & 7 of Charge No.2607 of Shalimar Tehsil, Charge No.26,028 of Shalimar Tehsil and Charge No.26,030 of Shalimar Tehsil may be excluded from NA-121 and be included in NA-120.



- ii. Circle No.1, 2, 3, 5, 6, 7, 8 and 9 of Charge No.18602 of Lahore Cantt Tehsil and Circle No.1, 3 and 4 of Charge No.18706 of Lahore Cantt Tehsil may be excluded from NA-120 and be included in NA-123.
- iii. Circle No.2, 5 and 6 of Charge No.18706 of Lahore Cantonment and Charge No.18707 of Lahore Cantonment may be excluded from NA-120 and be included in NA-122.

PROPOSAL OF NA-121 LAHORE

- i. Charge No.18701 and Charge No.18702 of Lahore Cantonment, Circle No.3 of Charge No.18605 of Lahore Cantt Tehsil, Charge No.18606, 18607 and 18608 of Lahore Cantt Tehsil may be excluded from NA-122 and be included in NA-121.
- ii. Charge No.18609 of Lahore Cantt Tehsil and Charge No.18568 of City Tehsil may be excluded from NA-128 and be included in NA-121.
- iii. Circle No.1, 2 and 7 of Charge No.26027 of Shalimar Tehsil, Charge No.26028 and 26030 of Shalimar Tehsil may be excluded from NA-121 and be included in NA-120.

8 The Petitioner No. 03 namely Mr. Muhammad Akmal through his counsel has initially contended that final delimitation has been done beyond actual and physical existence which is against the basic principles of convenience for the local residents. Therefore, the petitioner has proposed that the National Assembly constituency i.e NA-126 Lahore may be delimited as under:-

The Petitioner further elaborated that Charge No 57 is located near to NA-126 and constituency will become more compact, contiguous and convenient for the general public if it is included in NA-126. He further contended that 2 circles of Charge No. 4 of Model Town tehsil will be more convenient for public if it will be included in NA-124, as they were never part of NA-126.

9 The petitioners No. 04, 05, 06 & 07 namely Mr. Ahmad Naeem, Shahid Hussain Khan, Muhammad Usman and Salman Javaid, respectively, did not appear before the Commission today, however, their proposals in respect of National Assembly constituencies of district Lahore i.e. NA-118 Lahore II, NA-122 Lahore VI and NA-128 Lahore XII are as under:-

10 The counsel for the petitioner no. 08 Mr. Meesum Zaidi, Advocate appeared and submitted that his client is satisfied with the final delimitation of the Commission published on 30-11-2023.

11 The petitioner No. 09 namely Mr. Raza-ul-Karim through his counsel Mr. Mubeen uddin Qazi Advocate contended that his complete proposal was accepted by the Commission while deciding all the representations through order dated 26-11-2023. Therefore, he is fully satisfied with the final delimitation published by the Commission on 30-11-2023.

12 The petitioners No. 10 & 11 namely Mr. Muhammad Ijaz & Sharafat Ali appeared in person and submitted that they are satisfied with the final delimitation of the Commission published on 30-11-2023.

13. The Petitioner No. 12 namely Mr. Zulifqar Ali Bhatti through his counsel Mr. Rao Mudassar Azam Advocate appeared and supported the stance of Petitioner No. 03 Mr. Muhammad Akmal and his proposal is given below:-

14. The Petitioner No. 13 namely Mr. Ali Raza through his counsel Mr. Shahrukh Mahboob Advocate has also supported the final delimitation carried out by the Commission vide order dated 26-11-2023 and subsequently published on 30-11-2023.

15. The petitioner No. 14 namely Mr. Chaudhary Riaz Akhtar appeared in person and submitted that he is satisfied with the final delimitation of the Commission published on 30-11-2023.

16. The clerk of petitioner's counsel for the petitioner no.15 Mr. Rao Zaheer Iqbal and Javed Ahmed appeared and said that the senior counsel is busy before the Peshawar High Court and is not able to appear before the Commission.

17. All the parties present during hearing have been heard at length. The available record and maps have been perused.

18. The delimitation of constituencies is Constitutional cum legal mandate of this Commission. Preliminary delimitation was published by this Commission in accordance with the law/Rules. The voters of the Constituencies were given opportunity to file representations in accordance with Section 21 of



the Elections Act, 2017. The total population of District Lahore is 13,004,135 as per final results of Census-2023 officially published on 07th August, 2023. Further, as far as possible, variation in population of constituencies of an assembly is not required to exceed ten (10) percent, which as by the law has been determined on the basis of 5% above and 5% below margin; therefore, the constituency may be delimited 5% above or below the quota of seat, which is tabularized below:-

(Observations of the Commission)

19. The proposal of the Petitioner No.1 Muhammad Israeel was examined with the help of available record and maps which was partially accepted while deciding the representations on 26-11-2023. It is observed that in the writ petition before the Hon'ble Lahore High Court the petitioner has agitated that his remaining proposal is also feasible and is in accordance with principles of delimitation. Fresh proposal of the petitioner remanded by the Hon'ble Lahore High Court Lahore is to the extent of NA-120, 122, 123 & 125. The fresh proposals of the petitioner are:

- i Circle No.7 (Defence phase 5), 8(Defence Phase 2) &9 (small industry Society-Alfalah Town Bedian Road) of Charge No.18811 of Walton Cantonment having Population of 66,827 Excluded from NA-123 and included in NA-122 since the Cantonment's main Administration unit is located thereunder.
- ii Circle Nos 4 and 9 of charge No. 18602 of Lahore Cantt having population of 33,297 has been excluded from NA-120 and included in NA-123.
- iii Circle No.6 of charge no.18601 of Tehsil Cantt having population of 18890 has been excluded from NA-120 and included in NA-123.



- iv Circle No.2 of Charge No 26105 of Tehsil Raiwind having population of 16857 has been excluded from NA-125 and included in NA-123.
- v Charge No 18703 of Lahore Cantonment of Tehsil Cantt having population 48,547 has been excluded from NA-122 and included in NA-120.
20. The proposal of the petitioner was examined in detail and all the other objectors appeared before the Commission today, who had earlier filed the representations in respect of NA-120, 122 & 123 did not object the proposal of the petitioner Mr. Israeel. Therefore, the proposal of the petitioner No.01 is accepted on the following grounds:-
- i) The proposal of the petitioner is not disturbing the upper and lower limit of prescribed population quota.
 - ii) Majority of the area of Walton cantonment will be combine and the administrative unit of Walton cantonment will become in one and same constituency which will create public convenience.
 - iii) The proposal of the petitioner is not violating the principles of delimitation and also not violating the fundamental rights of voters.
 - iv) It will increase the facilities of communication for the general public.

21. The Petitioners No.2 namely Mr.Karamat Ali / Mr. Muhammad YounusAdeel and other have proposed changes in certain National Assembly constituencies through their earlier representation which was partially accepted. The fresh proposal of the petitioner remanded by Hon'ble Islamabad High Court is partially accepted to the extent of Circle No.07, 08 & 09 of Charge No.18811 of Walton cantonment and Circle No. 09 of Charge No. 18602 of Lahore Cantt Tehsil. Which has already been decided through accepting the petition of Mr. Israeel and rest of the proposal of the petitioner no. 2 is rejected on the following grounds.



- i) If the remaining proposal of the petitioner is accepted, it will disturb the population quota of NA-122. The population of NA-122 will cross the upper prescribed limit of population quota.
- ii) It will unnecessarily disturb the constituency of NA-127 and 128 for which the other objectors have shown their satisfaction in respect of final delimitation published on 30-11-2023.
- iii) Presently the shape of the constituencies are more compact and within prescribed population quota.

22. The proposal of the petitioner No.3 Mr. Muhammad Akmal has been perused in detail. The petitioner has requested for exclusion of circle No.1 and 2 of charge No.4 of Model Town Tehsil and its inclusion in NA-124 to intact the Model Town tehsil. He further proposed that Charge No.57 of City Tehsil, Lahore be included in NA-126 then the contiguity of the constituency will be better. The petitioner in his earlier representation against preliminary delimitation had proposed certain changes in six Constituencies i.e NA-124, 125, 126, 127, 128, and 129 without any lawful justification. The proposal of the petitioner was partially accepted to the extent of inclusion of charge No. 59 in NA-126, whereas the rest of the proposal is still not feasible. The petitioner intends to take out the areas of NA-129 and wants to include in NA-126 which has no connectivity with each other. Moreover, the petitioner has not pointed out any violation of principle of delimitation. If the proposal of the petitioner is accepted it will create inconvenience for the general public. Therefore, the remaining proposal of the petitioner is rejected.

23. Petitioners No 04 to 07 did not appear before the Commission.

24. The Petitioners No. 8, 9, 10, 11, 13 & 14 Mr. Mubashar Noman, Mr. Raza-ul Karim, Mr. Muhammad Ijaz, Mr. Sharafat Ali, Mr. Ali Raza & Chaudhry Riaz Akhtar have supported the final delimitation published by the Commission.

25. The petitioner No.12 Namely Zulfiqar Ali Bhatti has similar proposal with the petitioner No. 03 Mr. Muhammad Akmal therefore the instant



petition is decided in terms of the decision of petitioner No.03 Mr. Muhammad Akmal.

26. All the representations made in respect of National Assembly Constituencies of district Lahore has already been decided on 26-11-2023 in addition to it, partial modification of form 07 is allowed to the extent of petitions of Mr. Israeel and Karamat Ali. The office is directed to amend form-7 accordingly.
