SCHEDULE FOR CONDUCT OF LOCAL GOVERNMENT BYE-ELECTIONS 2025 TO THE VACANT WORKER RESERVED SEATS IN UNION COUNCILS NO. 3 AND 19 OF DISTRICT LORALAI, BALOCHISTAN PROVINCE.

No.F.2(15)/2025-LGE-B(2):- In exercise of the powers conferred upon it under Article 140(A)(2) of the Constitution of the Islamic Republic of Pakistan, Sections 16, 30(2)(2A) & 36 of the Balochistan Local Government Act, 2010 read with Rules-9 & 48 of the Balochistan Local Government (Election) Rules, 2013 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby calls upon the General Members of local councils concerned to elect the members against the vacant Worker Reserved Seats in Union Councils No. 3 and 19 (one seat in each UC) of District Loralai, Balochistan Province and in connection therewith appoints the following dates of various activities of elections.

- 2. To ensure that elections to the reserved seats are conducted honestly, justly, fairly in accordance with law and to ensure that the corrupt practices are guarded against, the Election Commission of Pakistan directs that:-
  - If any person in Government Service misuses his official position in any manner in order to influence results of the elections, he shall be liable to be proceeded against under the Law:
  - ii. After issuance of election schedule for the reserved seats of local government, no transfers / postings of the officers and Officials appointed in connection with election shall be made without prior approval of the Commission till the publication of election results:
  - iii. After the issuance of Election Schedule, the President, Prime Minister, Chairman / Deputy Chairman Senate, Speaker, Deputy Speaker of an Assembly, Federal Minister, Ministers of States, Governors, Chief Ministers, Provincial Ministers and Advisors to the Prime Minister and the Chief Minister, Mayor / Chairman / Naizm, their Deputies shall not participate in election campaign. However, members of any Assembly, Senate and Local Government are allowed to participate in the election campaign. They will strictly abide by the code of conduct, direction, instructions and regulations issued by the Election Commission of Pakistan and violations thereof shall entail legal consequences.
  - iv. No Government functionary or elected representative including a local government functionary or elected representative shall announce any development scheme in Local Councils, involved in Local Government byeelection, till the poll day.
  - v. After commencement of election activities as per schedule, no leave of the Officers and Officials appointed in connection with election on reserved seats will be granted without prior approval of the Commission till the publication of election results. In case leave has already been sanctioned, the officer will not relinquish his charge without approval of the Hon'ble Commission;
  - vi. Any holder of public office, who is found to have violated any provision of Election Laws or the instructions issued by the Election Commission, shall be proceeded against as mandated in Law;

#### Note:-

- The offices of the Election Commission as well as the offices of District Returning Officers and Returning Officers shall remain open on all public holidays if any activity provided in the schedule falls on that day.
- ii. All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hours and the said timing will also be followed on public holidays fixed for any electoral activity of the schedule.

- iii. The respective council hall or any Government building within the jurisdiction of the council concerned will be polling station for the election on reserved seats.
- iv. Separate election will be conducted for each category on same day.
- v. Polling Hours will be observed from 08:00 AM to 04:00 PM.
