ORDER

Sikandar Sultan Raja, Chairman- The subject declaration is referred by the Presiding Officer (Speaker) National Assembly, against the Respondent (MNA from NA-262) in terms of Article 63A of the Constitution of Islamic Republic of Pakistan (hereinafter referred as "the Constitution") for defection from Parliamentary Party of Pakistan Muslim League N (PML-N).

O2. Facts in brief forming background of the subject declaration necessary for decision are that the Respondent, contested election from NA-262 as an independent candidate who joined Pakistan Muslim League (N) after General Election 2024 while submitting an affidavit bearing No. C592106 for joining PML-N before the Election

Commission of Pakistan (hereinafter referred as "the Commission"). The subject reference was received from the Speaker National Assembly to the Commission on 21-10-2024 along with a declaration from the party head of PML-N under Clause 1 of Article 63A of the Constitution. The party head PML-N has declared that Mr. Adil Khan Bazai, MNA (Respondent) joined Pakistan Muslim League (N) after General Elections 2024 in writing. He further stated that the Respondent has defected from the Parliamentary Party PML-N on following grounds:-

DEFECTION FROM PML (N)

1. Mr. Adil Khan Bazai, a Member of the National Assembly (MNA), has defected from the Parliamentary PML (N) to join the Sunni Ittehad Council, evident from his actions in sitting on the opposition benches during National Assembly sessions. This shift in allegiance raises concerns about his commitment to his constituents and Parliamentary PML (N).

VIOLATION OF PARTY DIRECTION

2. On June 28, 2024, Mr. Bazai failed to vote on the Finance Bill 2024 (Money Bill), directly contravening the party direction set by the President of PML (N) on June 12, 2024. Furthermore, he consistently abstained from voting on demands for grants and the Money Bill, instead submitting leave applications to the National Assembly Secretariat, which were routinely approved along with those of other MNAs. This behavior indicates a disregard for party discipline.

SHOW CAUSE NOTICE

3. A show cause notice was issued to him by the Parliamentary leader on 05.08.2024 in terms of Clause 1 of Article 63A of the Constitution to provide an opportunity to him to explain his position, however, he did not respond to the above show cause notice.

O3. Therefore, the party head/President PML-N requested to de-seat the Respondent on the ground of defection under Article 63A of the Constitution.

O4. Upon receipt of the reference along with declaration from the Speaker National Assembly on 21-10-2024, the matter was fixed for hearing on 23.10.2024 with notice to the parties. On 23.10.2024 the copy of the reference was handed over to the learned proxy counsel for the Respondent and he was directed to file written reply on or before the next date of hearing which was 05.11.2024 with advance copy to the counsel for the Petitioner. On 05.11.2024, counsel for the Respondent submitted his reply which was taken on record and which also was handed over to the counsel for the Petitioner. The matter was adjourned to 12.11.2024 for final arguments. After hearing the arguments from both the parties the matter has been reserved for decision.

ARGUMENTS ON BEHALF OF PETITIONER

- Dearned counsel for the petitioner submitted that the directions from the party (PML-N) were issued regarding the presentation of the Federal Budget and voting on the Finance Bill 2024 to all the members of the Parliamentary Party on 12.06.2024 and 20.06.2024. He stated that the Money Bill was voted on 28.06.2024 and the Respondent did not vote on the Finance Bill 2024 contrary to the clear party directions of Parliamentary Party of PML-N. He added that a Show Cause notice was issued to the Mr. Adil Khan Bazai, MNA by the parliamentary leader on 05-08-2024 in term of clause (1) of Article 63 of Constitution for provision of an opportunity to explain his position however Mr. Adil Khan Bazai did not respond to the Show Cause Notice.
- Decition 104 (A) of the Elections Act, 2017 (hereinafter referred as "the Act, 2017") it is specifically provided that once a declaration consent or affidavit is submitted by an independent returned candidate for joining of a political party it shall be irrevocable and cannot be substituted or withdrawn. He further stated that the Respondent has filed a Civil Suit for declaration and cancellation of affidavit before the Civil Court, Quetta. He further mentioned that the subject case is filed on 02.11.2024 which is an afterthought. He argued that the affidavit was filed by the Respondent on 16.02.2024. He further added that in paragraph No. 3 of the Civil Suit filed by the Respondent which is at page No. 47 as annex-G along with the reply submitted by the Respondent, he contended that the affidavit dated 16.02.2024 is fake and bogus document and was never executed by the Respondent. He argued that in the same para the Respondent mentioned that he never authorized anyone to

execute the affidavit on behalf of the Respondent. However, the counsel for the Petitioner mentioned that the Respondent did not agitate that the signature or the thumb impression on the affidavit is fake. He also highlighted that the Civil Suit has been filed by the Respondent after a considerable delay and even after the declaration made by the President/ party head of PML-N under Article 63A(1) of the Constitution. The counsel for the Petitioner also stated that from February 2024 till October 2024, the Respondent did not file any application before the Commission regarding the affidavit dated 16.02.2024. He also mentioned that the status of the Respondent remained updated on the website of National Assembly and notification in this regard has also being issued by the Commission. He while concluding his arguments requested the Commission to confirm the declaration under Article 63A(3) of the Constitution and the Respondent may be de-seated on the ground of defection.

ARGUMENTS ON BEHALF OF RESPONDENT

On the other hand, the counsel for the Respondent appeared and stated that the 07. Respondent never joined PML-N, therefore, no question of defection or disqualification arises. The counsel for the Respondent argued that the Respondent never submitted affidavit bearing No.C592106 with respect to affiliation/joining of PML (N) before the Commission. He further argued that affidavit bearing No.C592106 is fake and fabricated. The counsel stated that initially the Respondent submitted the nomination papers to contest the General Elections 2024 on the party ticket of Pakistan Tehreek-e-Insaf. He added that due to the dispute of Intra Party election and symbol BAT, the Respondent contested General Elections 2024 as an independent candidate. He mentioned that the Commission issued the notification of the Respondent as an independent Returned Candidate on 15-02-2024. He further mentioned that the Respondent joined Sunni Ittehad Council (hereinafter referred as "SIC") through affidavit bearing No.C592106 on 20.02.2024. The counsel for the Respondent also referred the order passed by the Supreme Court of Pakistan in Civil Appeal No. 333/2024 order dated 23-09-2024 and argued that the Supreme Court of Pakistan has declared the independents candidates as candidates of PTI. He further stated that the Respondent may be treated as an independent Candidate as he contested election both as candidate and nominee of PTI, apart from the fact that nomination papers, as filed later were as an independent Candidate. Learned counsel for the respondent stated that he has also filed a complaint against the impugned affidavit bearing No. C592106 wherein a statement has been recorded

by the concerned investigation officer. He mentioned that the oath Commissioner who has attested the affidavit bearing No. C592106 has also stated through a statement that Mr. Adil Khan Bazai has never executed/ signed an affidavit before him and he never appeared before him to make any such statement on oath. He also highlighted that the Oath Commissioner further stated that he never verified the affidavit dated 16.02.2024 nor issued attestation thereof. Learned counsel for the respondent further contended that after thorough investigation in complaint filed by Syed Muhammad Ashraf working as Personal Assistant of Mr. Adil Khan Bazai (Respondent) against the Station House Officer (SHO), Police Station Civil Lines, Quetta before the Judicial Magistrate-X, Quetta, SHO has conducted an inquiry and submitted its report before the learned judicial Magistrate in which they found that impugned affidavit bearing No.C592106 is fake/ fabricated on the following reasons.

- 1. Oath Commissioner has recorded statement before the Police/ investigation officer that he has never attested verified the impugned affidavit bearing No.C592106.
- 2. CNIC of Mr. Adil Khan Bazai is wrongly mentioned.
- 3. No detail of stamp paper mentioned therein for verification.
- 4. Address of Witness namely Zarak Khan, CNIC No./ Phone No. and cast which are mentioned in the affidavit bearing No.C592106 is untraceable.
- 5. License of oath commissioner Saeed Ahmed Khan is not valid, he did not renew his license after 2019.
- Dearned counsel for the Respondent also argued that from the bare perusal of the affidavit bearing No. C592106, it reveals that three separate hand writings have been used on the above mentioned affidavit. He pointed out that the typed language reveals about the Provincial Assembly Seat, however, the Respondent belongs to National Assembly, moreover, there is no record of issuance of affidavit and no signature exists on the back of affidavit. The counsel also pointed out that two separate receiving dates have been mentioned on the acceptance letter submitted to the Commission with diary numbers 438 (19-02-2024) and 533 (18-02-2024). He further added that the Respondent has no objection if the Commission initiates an inquiry in this regard.
- O9. To conclude that learned counsel prayed that the instant reference may kindly be summarily rejected due to non-maintainability which was forwarded by the Mian Muhammad Nawaz Sharif through Speaker National Assembly.
- 10. We have heard the arguments advanced by the learned counsel for the parties and perused the record.

11. The subject declaration is made under Article 63A of the Constitution and the entire case revolves around Article *ibid*, therefore, same is reproduced for the ease of reference.

63A Disqualification on grounds of defection, etc. (1) If a member of a Parliamentary Party composed of a single political party in a House

a. resigns from membership of his political party or joins another Parliamentary Party; or

- b. votes or abstains from voting in the House contrary to any direction issued by the Parliamentary Party to which he belongs, in relation to
 - i. election of the Prime Minister or the Chief Minister; or
 - ii. a vote of confidence or a vote of no-confidence; or
 - iii. a Money Bill or a Constitution (Amendment) Bill;

he may be declared in writing by the Party Head to have defected from the political party, and the Party Head may forward a copy of the declaration to the Presiding Officer and the Chief Election Commissioner and shall similarly forward a copy thereof to the member concerned:

<u>Provided:</u> that before making the declaration, the Party Head shall provide such member with an opportunity to show cause as to why such declaration may not be made against him.

<u>Explanation:</u> "Party Head" means any person, by whatever name called, declared as such by the Party.

(2) A member of a House shall be deemed to be a member of a Parliamentary Party if he, having been elected as a candidate or nominee of a political party which constitutes the Parliamentary Party in the House or, having been elected otherwise than as a candidate or nominee of a political party, has become a member of such Parliamentary Party after such election by means of a declaration in writing.

(3) Upon receipt of the declaration under clause (1), the Presiding Officer of the House shall within two days refer, and in case he fails to do so it shall be deemed that he has referred, the declaration to the Chief Election Commissioner who shall lay the declaration before the Election Commission for its decision thereon confirming the declaration or otherwise within thirty days of its receipt by the Chief Election Commissioner.

(4) Where the Election Commission confirms the declaration, the member referred to in clause (1) shall cease to be a member of the House and his seat shall become vacant.

(5) Any party aggrieved by the decision of the Election Commission may, within thirty days, prefer an appeal to the Supreme Court which shall decide the matter within ninety days from the date of the filing of the appeal.

(6) Nothing contained in this Article shall apply to the Chairman or Speaker of a House.

(7) For the purpose of this Article —

a. "House" means the National Assembly or the Senate, in relation to the Federation; and a Provincial Assembly in relation to the Province, as the case may be;

b. "Presiding Officer" means the Speaker of the National Assembly, the Chairman of the Senate or the Speaker of the Provincial Assembly, as the case may be.

(8) Article 63A substituted as aforesaid shall comes into effect from the next general elections to be held after the commencement of the Constitution

(Eighteenth Amendment) Act, 2010.

<u>Provided:</u> that till Article 63A substituted as aforesaid comes into effect the provisions of existing Article 63A shall remain operative].

12. The provisions of Article 63A entails serious penal consequences of de-seating of members of Parliament and Provincial Assembly(s) as held by the august Supreme Court in its judgment reported in PLD 1998 SC 1263 "Wukala Mahaz Barai Tahafaz Dastoor Vs. Federation of Pakistan" in the following words:

"We are unable to agree with the submission of the learned Attorney-General, Ch. Muhammad Farooq and Mr. S. Sharifuddin Pirzada, learned senior counsel for the Federation, that paragraph (a) to explanation to clause (1) of Article 63A of the Constitution would also include the conduct of a member of the Parliament outside the House. The view, which I am inclined to take is also in conformity with the well-settled principle of interpretation that a penal provision should be construed strictly and its scope should not be extended unless it is so required by the clear language used therein or by necessary intentment. A member cannot be disqualified under Article 63A on the ground of his alleged misconduct committed outside the precinct of the Parliament, and I for that an action is to be taken according to the party constitution and not under Article 63A which regulates the conduct and behaviour of the members within the House of Parliament."

- 13. The making of declaration under Article 63A and its pre-requisite are provided in the Article itself. The subject issue is confined to the defection under clause (b)(iii) of Article 63A. The clause (b)(iii) says that if a member of a Parliamentary Party votes or abstain from voting in the House contrary to any direction issued by the Parliamentary Party to which he belongs, in relation to a money bill or a Constitution (Amendment) Bill. The vires of Article 63A was challenged before the Supreme Court in "Wukala Mahaz Barai Tahafaz Dastoor Vs. Federation of Pakistan" case reported in PLD 1998 SC 1263 and the august Court held that Article 63A is intra vires to the Constitution.
- 14. Upon receipt of the declaration under Clause 1 the Commission is bound to decide the declaration within 30 days of its receipt by the Chief Election Commissioner. The subject reference has been receipt by the Commission on 26.10.2024.

15. The declarations seeking defections varies on case to case basis. The act of defection has been seriously viewed and denounced by the august Supreme Court in an number of pronouncements few of which are reproduced as under:-

"Defection of elected members has many vice. In the first place, if the member has been elected on the basis of a manifesto, or on account of his affiliation with a political party, or on account of his particular' stand on a question of public importance, his defection amounts to a clear breach of confidence reposed in him by the electorate. If his conscience dictates to him so, or he considers it expedient, the only course open to him is to resign to shed off his representative character which he no longer represents and to tight a reelection. This will make him honorable politics clean, and emergence of principled leadership possible. The second, and -more important, the political sovereign is rendered helpless by such betrayal of its own representative. In the normal course, the elector has to wait for years, till new elections take place, to repudiate such a person. In the meantime, the defector flourishes and continues to enjoy all the worldly gains. The third is that it destroys the normative moorings of the Constitution of an Islamic State. (PLD 1992 Supreme Court 646)."

"This Court in number of its judgments described the Act of defection by elected members of the Assemblies as an immoral practice. The defection by members of political parties after their election as members of Assemblies led to the dissolution of more than one elected Assemblies in the past. There was strong condemnation by the public of the immoral practice of floor-crossing and defection by elected representatives of political parties after their election on party ticket as members of Assemblies. There was consensus amongst the political parties to eradicate the vice from the body politics of the country to restore the confidence of people in the political process. In this back set stringent legislative measures were needed to curb this immoral practice to keep the political process pure and clean." (PLD 1998 SC 1263)

"Defection on political parlance, as stated in Sabir Shah's case, means an act of political opportunism to obtain immoral gains and worldly advantages by expoiting one's representative and political statue. However, while enacting laws or introducing amendments in the Constitution with the object of eradicating the vice of defection, the Legislature as given in dictionary or it is understood in common parlance. The Legislature, therefore, while introducing Article 63A in the Constitution could give its own meaning to the word defection provided it bore reasonable nexus to meaning given in the dictionary or as it is understood commonly. The definition of defection provided under the Explanation appended to Article 63A in my opinion, bears reasonable nexus to its dictionary meaning and as this word is understood in common parlance.

"that disloyalty, treachery and corruption from the rank and file of the elected members to both the House Defection, horse-trading or floor-crossing by the members elected on a party ticket is the odious type of corruption so, on the principle that Courts should not lean to maintain ill-gotten gains may not

exercise discretion in favor of those who on one pretext or the other indulged in floor-crossing. AS such on this count too, we are not inclined to exercise discretion in favor of petitioner." (PLD 1995 SC 66)

"We may observe that the approach of the learned Chief Election Commissioner should be that the above Article 63-A of the Constitution which is intended to eliminate cancerous vice of defection which has brought bad name to our country and also political instability should not be rendered ineffective on account of raising of frivolous pleas before him. If we were to hold that the Chief Election Commissioner has no power to examine the above plea, it would render the above Article 63-A ineffective as it will be very easy for a member who has defected to challenge the status of the head of the political party involved before the Chief Election Commissioner and then to compel initiation of a civil proceeding which could not have been the intention of the framer of above Article 63-A of the Constitution. It also runs counter to clause (2) of Article 63, thereof, which is to be read in conjunction with above Article 63-A. (1999 SCMR 1921)"

- The second proviso of Article 51(6) of the Constitution provides that the independent candidates are required to join political party within 3 days of the publication of names of Returned Candidates. The Respondent submitted nomination papers from NA-262 Quetta-I on 20.12.2023 as an independent Candidate by marking ("i do not belong to any political party"). After the conduct of General Elections 2024 held on 08.02.2024, the Commission vide notification dated 15.02.2024 declared the Respondent as independent Returned Candidate from the Constituency NA-262 Quetta-I and 3 days time was available to him to join any political party in terms of Article 51 of the Constitution. On 17.02.2024 President PML-N forwarded an affidavit dated 16.02.2024 to the Commission which was received on 18.02.2024, declaring that the Respondent had joined Pakistan Muslim League (N) on 16.02.2024. The letter along with affidavit by the Respondent was placed before the Commission for approval. The Commission approved the letter along with affidavit on 19.02.2024 and declared him affiliated with PML-N which was conveyed to the National Assembly vide letter dated 25.04.2024.
- both dated 20.02.2024 were received to the Commission after lapse of mandatory period of three days as provided under Article 51(6) of the Constitution. It was stated in the letter that Mr. Adil Khan Bazai had joined SIC. The matter was again placed before the Commission and the request was declined on the ground that he had already joined another political party PML-N on 16.02.2024 within stipulated period of three days as notification of the Returned

Candidate was issued on 15.02.2024 and the Commission had already approved the said joining by the Respondent.

18. Newly inserted Section 104A vide Elections (Second Amendment) Act, 2024 and the second proviso of Rule 92(6) of the Election Rules, 2017 are clear in this scenario which provides that:-

ELECTIONS ACT, 2017

"104A. Consent for joining of political party by independent returned candidate to be irrevocable etc.- Notwithstanding anything contained in this Act or rules or any other law, for the time being in force, or a judgment, decree or order of any court including the Supreme Court and a High Court, the declaration, consent or affidavit, by whatever name called, of an independent returned candidate once given for joining a political party shall be irrevocable and cannot be substituted or withdrawn."

ELECTION RULES, 2017

"92(1)...... 92(2)...... 92(3)...... 92(4)...... 92(5).....

92(6) For the purpose of this rule, the expression—total number of general seats won by political party shall include the independent returned candidate or candidates who may duly join such political party within three days of the publication in the official Gazette of the names of the returned candidates:

Provided that if the independent candidate applies to the leader of a political party for joining his party then the leader of that political party will forthwith inform the Commission of joining of such candidate through a letter to be delivered to the Commission along with consent of that candidate duly attested by a Notary appointed under the Notaries Ordinance, 1961 (XIX of 1961) or an Oath Commissioner appointed under the Oaths Act, 1873 (X of 1873) or a Government servant in basic pay scale 17 and above:

Provided that the consent of the independent candidate so delivered to the Commission shall, in no circumstances, be open to recall or cancellation."

19. The above mentioned provisions of Act and Rules, 2017 categorically bars the submission, re-calling, cancellation or withdrawal of affidavit in respect of joining of political party within given time frame of three days or after lapse of it. It is mandatory for independent Candidate to join a political party within 3 days after his notification as Retuned Candidate. The subsequent affidavit dated 20.02.2024 submitted by the Respondent after 3

days of his notification is hit by Article 51(6) of the Constitution read with Section 104 of the Act and Rule 92 of the Election Rules, 2017. Insertion of new Section 104A in the Elections Act, 2017 through Elections Second Amendment Act, 2024 has been given retrospective effect from 2nd October, 2024 in other terms from the enactment of Elections Act, 2017. Furthermore, the Commission has also issued list of independent Returned Candidates in the National Assembly who joined different political party(s) and party position(s) through letter dated 25.04.2024 bearing No. F. 2(5)/2024-Coord. In the said list which was provided to the National Assembly, Mr. Adil Khan Bazai is reflecting at Sr. No. 256 having party affiliation of PML-N. Seven months have lapsed and the Respondent did not challenge the list of affiliation/ party position at any forum nor filed/ moved any application to the Commission in this regard. Furthermore, the Respondent did not bother to even inquire about the acceptance or rejection of affidavit dated 20.02.2024 regarding joining of SIC submitted by the Chairman SIC to the Commission.

The counsel for the Respondent stated that Mr. Adil Khan Bazai was un-aware regarding updation of his status as having party affiliation of PML-N. In this regard it is stated that the status of Mr. Adil Khan Bazai on the official website of National Assembly of Pakistan is still shown as party affiliation with PML-N. He has also taken oath as PML-N member on 29.02.2024. The hyperlinks showing the official page of National Assembly of Pakistan in which the details are mentioned regarding the party position of PML-N and party affiliation of Mr. Adil Khan Bazai are given below:-

21. The Respondent has also attached the documents of Civil Suit for declaration/cancellation of affidavit, permanent injunction and consequential relief, filed before the Court of Senior Civil Judge-I, Quetta on 02.11.2024. The matter is still pending adjudication and no final order has been passed by the Learned Civil Judge. The Learned Civil Court has suspended the affidavit bearing NO. C592106 till the next date of hearing. The said order for suspension of affidavit was passed on 02.11.2024 which do not have a retrospective effect and it will be taken as prospective effect. Moreover, Section 236 of the Elections Act, 2017 bars the jurisdiction of the courts regarding any action taken by the authority of the Commission, the Commissioner or an election official or any decision given by any of them

or any other officer or authority appointed under this Act or the Rules. The affidavit submitted by the Respondent on 16.02.2024 which was approved by the Commission on 19.02.2024 has been acted upon and the filing of the Civil Suit is an afterthought by the Respondent.

- It is also mentioned by the Counsel that a complaint under Section 200 of the 22. CRPC has also been filed in the Court of Judicial Magistrate-X, Quetta by Syed Muhammad Ashraf Personal Assistant of Mr. Adil Khan Bazai against the SHO, Police Civil Lines, Quetta for inquiry in the matter of submission of fake stamp paper and huge loss to Mr. Adil Khan Bazai and also for punishment to the culprits in the interest of justice. He referred an inquiry report by the SHO, PS, Civil Lines, Quetta, whereby, no order sheet or the order passed by the Magistrate has been produced before the Commission in which this report has been considered final or any final order relying upon this report has been passed by the Learned Judicial Magistrate Quetta. The said report has no binding effect upon the Commission even the Learned Magistrate is also not bound to pass an order while relying upon the report of the inquiry conducted by SHO, Civil Line, Quetta. Mere pendency of Civil or Criminal litigation even after lapse of considerable delay, do not declare the affidavit dated 16.02.20204 as fake, fabricated or forged document. Moreover, there is a maxum that "law is with the vigilant and not with the indolent" and "delay defeats equity". The Respondent has filed the civil suit just to dilute the situation even after passing of declaration by the party head. Furthermore, in the presence of the Respondent, the Criminal Complaint has been filed by an unknown person on his behalf showing him as Personal Assistant of the Respondent which is also against the spirit of the law.
- 23. The Constitution of Islamic Republic of Pakistan is a supreme document and all other laws are sub-ordinate to it. The Constitution of Pakistan has imposed certain duties upon the Commission along with certain powers. Article 63A(3) of the Constitution empowers the Commission and also imposes the duty upon it to decide the reference of declaration within 30 days of its receipt from the Speaker National Assembly. No doubt the record shows that at the time of presentation of Finance Bill 2024 (Money Bill) and voting upon it, the Respondent was affiliated with PML-N and admittedly he has not given vote as per the party directions issued on 12.06.2024 and 20.06.2024. He has also not given the reply of show cause notice. Even otherwise, the second affidavit regarding joining of SIC was time barred as notification of the Returned Candidate was issued on 15.02.2024 and the affidavit

was submitted on 20.02.2024 after the lapse of three days mentioned under Article 51 of the Constitution.

- The Respondent has also made admission during the hearing before the Commission that he has not given vote during the Finance Bill 2024 (Money Bill) from PML-N side while his status in the Commission and in the record of National Assembly of Pakistan is clearly shown him affiliated with PML-N.
- In light of the above findings, it is established and concluded that after being elected as independent Candidate, the Respondent joined PML-N on 16.02.2024 and that he has acted contrary to the directions issued by the Parliamentary Party on 12.06.2024 and 20.06.2024 and he did not vote in relation to the Finance Bill 2024 (Money Bill) which has established the factum of defection on the basis of the subject declarations against the Respondent. The declaration is confirmed and the Respondent cease to be the member of the National Assembly and his seat has become vacant.
