No.F.8(2)/2023-Cord.- In exercise of powers under Section 193 of the Elections Act, 2017 (Act No. XXXIII of 2017), the Election Commission hereby authorizes the Presiding Officers appointed for each Polling Station of following constituencies of National Assembly of Pakistan, to exercise the powers of a Magistrate of the First Class under the Code of Criminal Procedure, 1898 (Act No.V of 1898) from **15th March, 2023 to 17th March, 2023** in respect of the offences punishable under Section 169 of Elections Act, 2017 and Section 171 of Elections Act, 2017 punishable under Section 174 of Elections Act, 2017 (Act No. XXXIII of 2017) and may take cognizance of any such offence under Section 190 of the Code of Criminal procedure and shall try it summarily under Chapter XX of the Code.
