No.F.9(1)/2023 Elec-I (Vol-I):- In compliance with the order passed by Hon'ble Election Commission in W.P. 8043/2023, 4072/2023 and 4053/2023 regarding delimitation of National Assembly Constituencies No. NA-120 Lahore-IV, NA-122 Lahore-VI, NA-123 Lahore-VII and NA-125 Lahore-IX of Lahore District, the Commission heard the petitioners at length and disposed of the same vide order dated 12.12.2023. Accordingly ECP's Notification of even number dated 30th November, 2023 regarding final delimitation of National Assembly Constituencies is partially modified to the extent of following Constituencies which shall be read as under:


